The Summer School aims at providing participants with an in-depth understanding of the legal rules governing international contracts and the specific techniques of international contract-drafting. The course will deal with the different sources of law applicable to international contracts, as well as with a number of selected substantive issues, and relevant model contract clauses, of primary relevance in international contract practice.

### Target group and prerequisites for admission

The School is addressed to 2<sup>nd</sup>-level degree and PhD students, as well as to legal professionals and other business operators involved in international contract practice. A good level of English is a fundamental prerequisite for admission.

### Instructors

Instructors will include top-level academics and professionals in the field, such as: Prof. **Ronald A. Brand** (University of Pittsburgh, School of Law, US Delegate at the Hague Conference of Private International Law), Prof. **Petros Mavroidis** (Columbia Law School, New York and University of Neuchâtel), Prof. **Franco Ferrari** (Univ. of Verona, former Legal Officer at Uncitral), Prof. **Stefano Giubboni** (Univ. of Perugia) and others, as well as several professors from Bologna Law School teaching in the field of transnational contract practice.

### Credits and evaluation

Students attending the School will be granted 4 CFU. Participation to the programme shall grant up to 24 credits assignable to lawyers enrolled in any Italian Bar association, under Art. 3 of the Statute of July 13, 2007 approved by the *Consiglio Nazionale Forense*, governing lawyers' duties of continuing legal education.

### General Information

Classes will meet at the Faculty of Law in Ravenna every day from Monday to Friday, six to eight hours per day, up to a total weekly amount of 32 hours. All classes will be in English.

### Admission

Applications should be sent only via e-mail to the following e-mail address: **master@fondazioneflaminia.it** with a CV accompanied by a cover letter not later than **May 31, 2009**.

Participants will be selected on the basis of their curricula and their motivation as expressed in the cover letter. A good level of English is a mandatory prerequisite for admission. Late applications may be considered, depending on the number and eligibility of the applications already received.

Cancellation policy: cancellation will be possible without any charges by May 31, 2009; for cancellations made after May 31, 2009 but before the beginning of the School, a 20% cancellation fee may apply".

### Fees

€ 380 = including application fee, teaching materials, guided tours and social events, but excluding accommodation and meals.
